You agree to abide by the terms and conditions before skating at the facility. You also acknowledge that you have had the opportunity to seek clarification from The Surfer Kids staff on any of the following points:

- If the skater is under 18, this form must be signed by a parent or legal guardian who is over 18.
- For skaters under 12, the accompanying parent or legal guardian must remain present at the Bitcoin Bowl for the duration of the skate session.
- All skaters under the age of 18 must wear full protective gear, including a helmet, wrist guards, elbow pads, knee pads, and skate shoes. While it is strongly advised for those over 18 to also wear full protective gear, they may choose to skate without it at their own discretion and risk.
- Please note that The Surfer Kids staff cannot always directly monitor participants and each participant participates at their own risk.
- I acknowledge and accept that I attend the Bitcoin Bowl solely at my own risk. I agree that The Surfer Kids shall not be liable for any physical injuries or losses I may sustain. I also agree to waive all liability and claims against The Surfer Kids, the Bitcoin Bowl, its directors, trustees, employees, volunteers, or landlords.
- Skateboarding activities are not recommended for persons with heart, back, or neck conditions, or for those who are pregnant. If you suffer from any health problems, illness, or are pregnant, please consult your doctor for medical advice before visiting and participating in any activities at The Surfer Kids Center.
